All presentation proposals shall be submitted by email to office@adtsea.org *no later than February 28, 2022*. Please fill out pages 3-4 and return to the ADTSEA Office.

Presentations marketing or selling products or services shall not be considered.

Presentation topics may not be changed without prior written approval from ADTSEA.

Presenters are expected to give a professional high-quality presentation relating to Driver Education and Traffic Safety topic areas listed on page 2.

Presentations shall allow for participant interaction, stay on schedule and provide a minimum of 10 minutes at the end for participant questions. ADTSEA does not provide honorariums or travel expenses for presenters.

Presenters shall submit their final presentation electronically to the ADTSEA at office@adtsea.org a minimum of 10 working days prior to the conference.

Presenters shall notify ADTSEA at office@adtsea.org as soon as possible if they are unable to do their presentation at the ADTSEA conference. These presenters may identify a replacement and submit the replacement's bio. ADTSEA will notify the original presenter and replacement if the change was accepted.
